The General Resolutions Committee met at the PSAC-Quebec Montréal Regional Office on January 31, February 1 and February 2, 2017.

During its deliberations, the Committee reviewed 70 resolutions. Unless otherwise indicated, all were originally submitted in French.

The Committee also looked at the updated Resolutions of Record, which include 63 resolutions.

To reduce the number of documents printed at Convention and to go green, PSAC-Quebec has developed a new way of presenting its Committee reports.

The title and originator (originating body) of the resolutions are included in the report.

General resolutions are included in the report rather than as a separate package. They follow the order of priority established by the Committee.

Combined general resolutions and original general resolutions used to create a combined general resolution are in Appendix A, based on the established order of priority.

Finally, Appendix B contains a list of acronyms for originators of resolutions dealt with in this report.

## Resolution G-24 (Part 1) (which covers Resolutions G-21, G-22 and G-23)

Originator: STEP 10800

The Committee has split resolution G-24 into two parts.

#### Part 1:

The Committee recommends concurrence in Part 1 of Resolution G-24, which reads as follows:

HARASSMENT

SOURCE: STEP 10800 LANGUAGE OF ORIGIN: F

**WHEREAS** close to one out of six student workers is a victim of harassment in the university work environment;

**WHEREAS** this is an under-reported problem;

**BE IT RESOLVED THAT** PSAC-Quebec commit to actively combatting harassment of any kind;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec provide financial, human and material resources to locals planning initiatives to address the problem.

#### Rationale:

The Committee recommends concurrence in the first BIR because it believes that we must act quickly to put a stop to the scourge of workplace harassment.

## **Resolution G-46**

## Mental Health in the Workplace

PSAC-Quebec Regional Women's Committee

The Committee recommends concurrence in Resolution G-46 which reads as follows:

**WHEREAS** mental health problems can have a negative impact on all aspects of a person's life, including the workplace, and in some settings where there is mental health support, there is still a stigma associated with talking about it;

WHEREAS the associated costs are 51 billion dollars, which include absenteeism, medication and health care, and one in five Canadians will experience mental health issues during their lifetime:

**BE IT RESOLVED THAT** PSAC prioritize mental health in the workplace and take the necessary steps to urge the federal and provincial governments to make mental health support a priority and compulsory in our workplaces.

#### Rationale:

The Committee recommends concurrence in this resolution because mental health affects everyone.

## Resolution G-47 Domestic Violence

Originator: PSAC-Quebec Regional Women's Committee

The Committee recommends concurrence in Resolution G-47 which reads as follows:

**WHEREAS** domestic violence in an increasing problem and its repercussions have an impact on the workplace;

**WHEREAS** it is important for victims of domestic violence to know that their position and job stability will not be affected while they seek the help they and their family need;

**WHEREAS** it is vital for victims of domestic violence to have financial security from their employment to be able to leave an abusive spouse and take care of themselves and their family;

**BE IT RESOLVED THAT** PSAC negotiate the inclusion, in all of its collective agreements, of measures to support and protect victims of domestic violence, including leave with pay, and that it ensure that this issue remains a priority at the bargaining table;

**BE IT FURTHER RESOLVED THAT** PSAC pressure the federal and provincial governments to amend legislation to provide leave with pay to any victim of domestic violence and guarantee job security of all workers.

#### Rationale:

The Committee recognizes the importance and urgency of taking action in support of victims of domestic violence.

Composite Resolution G-1A (which covers Resolutions G-1, G-2, G-59, G-60 and G-61) Research Funding

Originator: Montréal Area Council

The Committee created Composite Resolution G-1A further to Resolutions G-1 (Montréal Area Council), G-2 (SERUM 17751), G-59 (STEP 10800), G-60 (ASTRE 12555) and G-61 (ASSEP 17753), which reads as follows:

WHEREAS university unions represent more than 25,000 PSAC-Quebec members;

**WHEREAS** salaries paid to research employees depend on research grants awarded by federal and provincial government granting agencies and not on university operating budgets;

**WHEREAS** the funds granted undermine compliance with the salary scales found in collective agreements;

**WHEREAS** the public research funding structure creates job insecurity for all employees;

**WHEREAS** PSAC has a duty to defend the jobs of its members;

**BE IT RESOLVED THAT**, effective immediately, PSAC and PSAC-Quebec take political action to ensure that government granting agencies take into account wages negotiated into the collective agreement when allocating subsidies.

**BE IT FURTHER RESOLVED THAT** PSAC and PSAC-Quebec lobby for an increase in these agencies' budgets to ensure that members' jobs are protected.

The Committee recommends concurrence in Resolution G-1A.

#### Rationale:

The Committee recommends concurrence in this resolution because it acknowledges the importance of supporting research while being in compliance with salaries that have been negotiated. The Committee also believes that budgets must be increased to maintain the number of research jobs.

Composite Resolution G-67A (which covers Resolutions G-67, G-68, G-69, G-70 and S-13-2nd BIR)

**Expansion of Organizing Unit** 

Originator: ASSEP 17753

The Committee created Composite Resolution G-67A further to Resolutions G-67 (ASSEP 17753), G-68 (Québec Area Council, G-69 (ASTRE 12555), G-70 (STEP 10800) and S-13-2nd BIR (ASSEP 17753), which reads as follows:

**WHEREAS** unionization of the university sector is fragile in Quebec and virtually non-existent in the rest of Canada:

**WHEREAS** the unionization effort must be followed by a mobilization effort in order for it to be sustainable;

WHEREAS unionization is beneficial in all workplaces and regions;

**BE IT RESOLVED THAT** PSAC and PSAC-Quebec expand their organizing activities involving college and university students throughout Quebec and Canada;

**BE IT FURTHER RESOLVED THAT** PSAC and PSAC-Quebec expand the mandate of the organizing unit to strengthen certificates.

The Committee recommends concurrence in Resolution G-67A.

#### Rationale:

The Committee believes that all new union certification is a step forward in improving working conditions. Furthermore, it recognizes that it is equally important to maintain existing conditions.

Composite Resolution G-62A (which covers Resolutions G-62, G-63, G-64, G-65 and G-66)

## Orphan clauses

Originator: STEP 10800

The Committee created Composite Resolution G-62A further to Resolutions G-62 (STEP 10800), G-63 (ASTRE 12555), G-64 (Montréal Area Council), G-65 (SERUM 17751) and G-66 (ASSEP 17753), which reads as follows:

**WHEREAS** those who have fought for decent working conditions must build on this legacy for future generations;

WHEREAS orphan clauses widen the gap between generations of workers;

**WHEREAS** orphan clauses have an adverse effect on new employees as pertains to their wages, pension plans, group insurance coverage and all other working conditions;

**BE IT RESOLVED THAT** PSAC and PSAC-Quebec take a stand against incorporating orphan clauses into collective agreements;

**BE IT FURTHER RESOLVED THAT** PSAC and PSAC-Quebec, along with their labour allies, lobby government at all levels to amend the Canada Labour Code and relevant provincial legislation accordingly.

The Committee recommends concurrence in Resolution G-62A.

#### Rationale:

The Committee believes that disparity in treatment is totally unacceptable and causes conflict between workers.

Composite Resolution G-28A (which covers Resolutions G-28, G-29, G-30, G-31 and G-32)

Increase of minimum wage to \$15 per hour

Originator: Québec Area Council

The Committee created Composite Resolution G-28A further to Resolutions G-28 (Québec Area Council), G-29 (Quebec Council), G-30 (ASSEP 17753), G-31 (STEP 10800) and G-32 (ASTRE 12555), which reads as follows:

WHEREAS minimum wage must be increased to allow all workers to live with dignity;

WHEREAS it is a mobilizing issue for Quebec society as a whole;

**WHEREAS** there are a number of campaigns under way to promote a minimum wage increase, and the lack of coordination among these campaigns is hindering progress as a whole;

**BE IT RESOLVED THAT** PSAC and PSAC-Quebec demand that the federal and provincial governments immediately raise minimum wage to \$15 per hour;

**BE IT FURTHER RESOLVED THAT** PSAC and PSAC-Quebec commit to pressuring the provincial and federal governments, FTQ affiliates and companies affiliated with the Fonds de solidarité FTQ so that they pay their employees a minimum wage of \$15 per hour;

**BE IT FURTHER RESOLVED THAT** PSAC and PSAC-Quebec participate in the merging of campaigns to increase minimum wage to \$15 per hour, namely with the 15plus.org campaign.

The Committee recommends concurrence in Resolution G-28A.

#### Rationale:

The Committee recognizes the importance and urgency of raising minimum wage to \$15 per hour.

**Resolution G-42** 

**Quebec election** 

Originator: Quebec Council

The Committee recommends concurrence in Resolution G-42 which reads as follows:

**WHEREAS** the Couillard government is similar to the former Harper government;

**WHEREAS** PSAC members in Quebec are subject to decisions of the Couillard government as workers and citizens, particularly in the areas of health, education and child care services;

**WHEREAS** thousands of PSAC members in Quebec rely on provincial government funding, particularly for postsecondary education;

**BE IT RESOLVED THAT** PSAC-Quebec develop a campaign in preparation for the 2018 Quebec election.

## **Rationale:**

The Committee firmly supports this resolution, given the harmful impact of the Quebec Liberal government's destructive policies on the living conditions of our members and their families.

# Resolution G-6 (which covers Resolution G-7) Anti-Scab Legislation

Source: Montréal Area Council

The Committee recommends concurrence in Resolution G-6 which reads as follows:

**WHEREAS** the presence of scabs could lead to violent incidents;

WHEREAS the right to strike is critical and could facilitate a return to the bargaining table;

**WHEREAS** the presence of scabs undermines the power of unions when a strike is called;

**WHEREAS** Quebec has legislation to address this issue;

**BE IT RESOLVED THAT** PSAC continue to urge political parties to introduce anti-scab legislation similar to that which is in effect in Quebec;

**BE IT FURTHER RESOLVED THAT** PSAC promote this bill within its own structure, other unions and political parties in Parliament.

### Rationale:

The Committee believes that the lack of such federal legislation violates the right of workers to negotiate on an equal footing with their employers.

# Resolution G-11 (which covers Resolutions G-10 and G-12) Pay parity clause

Originator: SERUM 17751

The Committee recommends concurrence in Resolution G-11 which reads as follows:

**WHEREAS** more than 50,000 Quebec workers from all walks of life have negotiated a pay equity clause with the public and parapublic sector (trailer clause);

**WHEREAS** the government wage policy (GWP) adopted on September 30, 2016 provides for lump sums of \$0.30 and \$0.16 per hour worked April 1, 2015 and April 1, 2019, respectively;

**WHEREAS** the intent of negotiating pay equity clauses was to apply the GWP, regardless of its form;

**WHEREAS** the government of Quebec refuses to award the lump sum payments to those subject to pay equity clauses;

**WHEREAS** many Quebec workers affected by this unfair measure earn less than \$15 per hour;

**BE IT RESOLVED THAT** PSAC-Quebec pressure the provincial government to grant lump sum payments agreed to under the 2015-2019 GWP to those subject to pay equity clauses linked to the GWP (trailer clause).

The Committee believes that employees who negotiated the trailer clauses are eligible to receive lump sum payments agreed to under the 2015-2019 GWP.

# Composite Resolution G-34A (which covers Resolutions G-34 and G-35) Legal and social protection for workers in atypical jobs

Originator: ASSEP 17753

The Committee created Composite Resolution G-34A further to Resolutions G-34 (ASSEP 17753) and G-35 (STEP 10800) which reads as follows:

**WHEREAS** the labour market has changed significantly over the past fifty years;

**WHEREAS** atypical employment has greatly increased and now makes up one third of the workforce;

**WHEREAS** labour legislation has not considerably evolved for several years and excludes workers in atypical jobs from the legal system;

WHEREAS PSAC represents many workers in atypical jobs;

**BE IT RESOLVED THAT** PSAC and PSAC-Quebec take a stand and actively advocate for better legal and social protection for workers in atypical jobs.

The Committee recommends concurrence in Resolution G-34A.

#### Rationale:

The Committee supports this resolution and recognizes that atypical work increases job insecurity.

**Resolution G-48** 

**Reinvestment in Education** 

Originator: Quebec Council

The Committee recommends concurrence in Resolution G-48 which reads as follows:

**WHEREAS** significant cuts to education have been made in the past two years;

**WHEREAS** the quality of education has seriously deteriorated:

**WHEREAS** society's future depends on the education of future generations;

BE IT RESOLVED THAT, immediately following the 2017 PSAC-Quebec Convention, PSAC-Quebec lobby the Quebec government to reinvest massively in education.

Rationale:

The Committee recognizes the importance of education for future generations.

## Resolution G-5 (which covers Resolutions G-3 and G-4 Transparency and accessibility of PSAC bodies

Originator: STEP 10800

The Committee recommends concurrence in Resolution G-5 which reads as follows:

**WHEREAS** PSAC is a large union with several bodies, and those bodies have a number of projects;

**WHEREAS** new members and delegates often have difficulty navigating around the union's various bodies;

**WHEREAS** a clear position book allows for meaningful tracking of the issues that are important to PSAC members;

**BE IT RESOLVED THAT** PSAC-Quebec ensure the availability and accessibility of the minutes of each of its bodies;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec develop and make available a central book stating its positions;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec pressure the PSAC National Office to develop and make available a position book;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec distribute documents explaining PSAC's structure, mandates and positions, and how each of its bodies operates.

#### Rationale:

The Committee believes that the information should be available to all members.

## Resolution G-8 [which covers Resolution G-9]

Pension plan for organizations under federal jurisdiction

Originator: Montréal Area Council

The Committee recommends concurrence in Resolution G-8, which reads as follows:

**WHEREAS** the current federal government was elected on a promise to restore government respect for its employees and to ensure retirement security for Canadians;

**WHEREAS** the government recently introduced a bill [C-27] that would allow federally regulated employers to change their employees' pension plan, even retroactively in the case of employees who have already retired;

**WHEREAS** Hassan Yussuf, President of the Canadian Labour Congress, wrote a letter to the Minister of Finance, explaining in particular that Bill C-27 was introduced without prior notice or consultation with Canadians, pensioners or unions, and it proposes measures that directly contradict the election promises made to improve retirement security for Canadians;

**BE IT RESOLVED THAT** PSAC-Quebec actively support PSAC's National Office in doing everything it can to have Bill C-27 dropped or, at least, to ensure that the government does not take advantage of the bill to impose the same type of change unilaterally imposed on public service employees.

The Committee believes that PSAC-Quebec should actively and fully support PSAC national campaigns against Bill C-27.

## Resolution G-16 [which covers Resolutions G-17 and G-18] Enhancement of the Régie des rentes du Québec (RRQ)

Originator: Montréal Area Council

The Committee recommends concurrence in Resolution G-16 which reads as follows:

**WHEREAS** 47% of retirees in Quebec need the Guaranteed Income Supplement [social assistance for retirees];

**WHEREAS** enhancement of the RRQ would improve coverage for all workers and would immediately raise the standard of living of the poorest;

**WHEREAS** low retirement income leads to slow economic growth and puts pressure on government-funded social services;

**WHEREAS** enhancement of the RRQ would significantly reduce the cost and risk of the existing supplemental pension plans while closing the gap between those with a pension and those without, which is both a social and a political issue;

**WHEREAS** employer-sponsored private pension plans are less and less common;

**WHEREAS**, according to the RRQ, only 27% of workers have "a high earning potential for income replacement";

**WHEREAS**, with the exception of Quebec, all Canadian provinces have signed the Vancouver agreement on enhancing the Canada Pension Plan [CPP];

**BE IT RESOLVED THAT** PSAC-Quebec pressure the provincial government to enhance the Quebec Pension Plan [RRQ] to the level announced for the CPP in the Vancouver agreement.

#### Rationale:

The Committee believes that all citizens of Quebec have the right to a decent retirement.

Resolution G-20 [which covers resolution G-19]

Amendment to the Employment Insurance Act

Originator: SERUM 17751

The Committee recommends concurrence in Resolution G-20 which reads as follows:

**WHEREAS** over 60% of the Canadian population, both unionized and non-unionized, does not have access to disability insurance;

**WHEREAS** employment insurance is largely funded by workers and must be used to protect our wages;

**BE IT RESOLVED THAT** PSAC actively lobby to amend section 12[3][c] of the Employment Insurance Act, which provides for a cap of fifteen [15] weeks of benefits payable in case of illness and that this period be significantly extended to reflect the reality of claimants and the varying length of time they may require depending on the type of disability.

## **Rationale:**

The Committee believes that fifteen [15] weeks of benefits payable in case of illness is clearly inadequate.

Composite Resolution G-25A [which covers Resolutions G-25, G-26 and G-27] Unpaid Internships

Source: ASSEP 17753

The Committee created Composite Resolution G-25A further to Resolutions G-25 [ASSEP 17753], G-26 [Québec Area Council] and G-27 [STEP 10800], which reads as follows:

UNPAID INTERNSHIPS ORIGINATOR: STEP 10800 LANGUAGE OF ORIGIN: F

**WHEREAS** many trainees and interns are currently not being paid for their 40-hour work week and must take on additional part-time work to make ends meet;

**WHEREAS** trainees and interns work as hard as employees and receive no remuneration;

**WHEREAS** an education should not be obtained at the expense of a student's quality of life:

**BE IT RESOLVED THAT** PSAC pressure the provincial and federal governments to prohibit unpaid placements and internships;

**BE IT FURTHER RESOLVED THAT** all trainees and interns working at PSAC, or for one of its bodies or locals, be remunerated.

The Committee recommends CONCURRENCE in the first BIR in Resolution G-25A.

## Rationale:

The Committee believes that placements and internships should be remunerated.

#### **Resolution G-33**

## Campaign to improve minimum working conditions

Originator: SETUE 10721

The Committee recommends concurrence in Resolution G-33 which reads as follows:

**WHEREAS** minimum working conditions are important to non-unionized workers and the most vulnerable unionized workers:

**WHEREAS** it is unacceptable for workers to live below the poverty line;

**WHEREAS** quality of life must not be restricted to the privileged;

**BE IT RESOLVED THAT** PSAC-Quebec demand that work schedules be provided to workers at least five [5] days in advance and that minimum wage be increased to \$15 per hour;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec advocate for ten [10] sick days per year for everyone, as well as for an increase in the minimum vacation leave for all workers to five [5] paid vacation weeks per year;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec make all of the political submissions needed to achieve these goals and that it produce information materials to advance these issues.

The Committee believes that good working conditions improve the quality of life of workers.

The Committee created Composite Resolution G-38A further to Resolutions G-36 [ASSEP 17753], G-37 [STEP 10800] and G-38 [ASTRE 12555], which reads as follows:

COMMERCIALIZATION OF KNOWLEDGE ORIGINATOR: ASTRE 12555 LANGUAGE OF ORIGIN: F

**WHEREAS** a society's future depends on the education of its future generations;

**WHEREAS** fundamental and applied research contributes to student education and advances the society that promotes it;

**BE IT RESOLVED THAT** PSAC call on the federal and provincial governments to reinvest in federal and provincial granting agencies;

**BE IT FURTHER RESOLVED THAT** PSAC insist on massive funding for fundamental and applied research intended for a non-commercial purpose;

The Committee recommends concurrence in Resolution G-38A.

#### Rationale:

The Committee recognizes the importance of supporting fundamental and applied research.

# Composite Resolution G-39A [which covers Resolutions G-39, G-40 and G-41] Progressive Tax System 1

Originator: ASSEP 17753

The Committee created Composite Resolution G-39A further to Resolutions G-39 [ASSEP 17753], G-40 [ASTRE 12555] and G-41 [STEP 10800]), which reads as follows:

PROGRESSIVE TAX SYSTEM 1

**ORIGINATOR: ASSEP 17753** 

LANGUAGE OF ORIGIN: F

WHEREAS workers are doing more than their fair share to maintain high-quality public

services;

WHEREAS the current tax system provides an unwarranted advantage to individuals

whose income is well above average;

BE IT RESOLVED THAT PSAC call for the establishment of progressive tax measures

such as bringing back the capital gains tax, adding tax brackets, increasing corporate

taxes and combatting tax havens.

The Committee recommends concurrence in Resolution G-39A.

Rationale:

The Committee supports this resolution because it recognizes that there is a flagrant

imbalance in the current tax system.

**Resolution G-43** 

**New resolution on retirement benefits** 

**ORIGINATOR: USGE 10032** 

The Committee recommends concurrence in Resolution G-43 which reads as follows:

WHEREAS the union has been fighting for better conditions for members, including a

**WHEREAS** a pre-retirement course would be very popular among members;

**BE IT RESOLVED THAT** PSAC provide a tailored pre-retirement course to all members;

BE IT FURTHER RESOLVED THAT the program be designed to provide information to

members about their pension plan;

BE IT FURTHER RESOLVED THAT the program aim to better prepare members for their

retirement.

Rationale:

**Resolution G-45** 

Union training vs. work-life balance

Originator: AGR 10080

The Committee recommends concurrence in Resolution G-45 which reads as follows:

WHEREAS most union training takes place on Fridays and Saturdays;

WHEREAS Saturday is a day of rest based on most of our members' work schedules;

**WHEREAS** we are increasingly asking the employer to value and respect work-life balance, as well as personal well-being and mental health;

**WHEREAS** those involved in union work already give a great deal of their time in addition to their regular work;

**BE IT RESOLVED THAT** PSAC-Quebec establish a task force to study viable alternatives to decrease, as much as possible, the training that occurs on weekends, without increasing our members' dues.

### Rationale:

The Committee recognizes the importance of work-life balance.

Resolution G-49
Drug costs

The Committee recommends concurrence in Resolution G-49 which reads as follows:

**WHEREAS** Quebec has entered into an agreement with pharmaceutical companies to purchase their medications at the best price available in Canada;

**WHEREAS** pharmaceutical companies have entered into secret agreements with other provinces at no benefit to Quebec;

**WHEREAS** pharmaceutical companies have failed to comply with the agreement with the government of Quebec concerning drug prices;

**BE IT RESOLVED THAT** PSAC-Quebec lobby the Quebec government to prosecute pharmaceutical companies that do not comply with the agreement on drug prices.

## Rationale:

The Committee believes that there is unfair pricing of drugs across Canada.

#### **Resolution G-50**

## Universal Drug Insurance Plan

Originator: Quebec Council

The Committee recommends concurrence in Resolution G-50 which reads as follows:

**WHEREAS** the cost of drugs is increasing exponentially in Quebec;

**WHEREAS** Canada is one of the Organisation for Economic Co-operation and Development (OECD) countries that has seen the greatest increase in the cost of drugs over the past decade;

**WHEREAS** the cost of drugs has stabilized in some OECD countries that have set up universal drug insurance plans;

**WHEREAS** the introduction of universal drug insurance could save us up to 2.7 billion, according to studies by Carleton University professor Marc-André Gagnon;

**WHEREAS** drugcost pressures on private plans will be untenable in the short term for both employers and workers;

**BE IT RESOLVED THAT** before PSAC-Quebec 2020 Convention, PSAC-Quebec lobby the provincial government to set up a universal drug insurance plan.

#### Rationale:

The Committee believes that the increase in drug costs must be curbed and that drugs must be more accessible to all Canadians.

#### **Resolution G-51**

Scholarship to provide financial support to women pursuing graduate studies in Science, Technology, Engineering, Medicine and Math

Originator: Québec Area Council

The Committee recommends concurrence in Resolution G-51 which reads as follows:

**WHEREAS** PSAC can take a leadership role in feminist struggles;

**WHEREAS** women are still under-represented in these graduate fields of study and the women enrolled in them routinely face various forms of sexism;

**WHEREAS** it is important to encourage women enrolled in these fields of study and given that a scholarship is a form of recognition and provides substantial financial support to students;

**BE IT RESOLVED THAT** PSAC undertake to establish a scholarship to recognize and encourage women in graduate programs in the fields of Science, Technology, Engineering, Medicine and Math.

#### Rationale:

The Committee agrees with this resolution because it considers women to be underrepresented in these fields.

The following members of the Committee wish to be recorded against the Committee's recommendation: : Annick Lamoureux and Yolande Dostie.

## Reason for non-concurrence:

The scholarship should not be offered for specific fields, but rather for all fields. Restricting the scholarship to specific fields creates discrimination.

Composite Resolution G-55A (which covers Resolutions G-55 and G-56) **Progressive Tax System 2** 

Originator: ASTRE 12555

The Committee created Composite Resolution G-55A further to Resolutions G-55 (ASTRE 12600) and G-56 (STEP 10800), which reads as follows:

PROGRESSIVE TAX SYSTEM 2 ORIGINATOR: ASTRE 12555 LANGUAGE OF ORIGIN: F

**WHEREAS** the media is saturated with talk about debt and the neo-liberal plan to get out of debt;

**WHEREAS** the Institut de recherche et d'informations socio-économiques (IRIS) conducts scientific research to benefit workers and does not have sufficient resources to meet its goals;

**BE IT RESOLVED THAT** PSAC and PSAC-Quebec promote research on progressive tax measures by financially supporting IRIS and asking its affiliates to do the same.

The Committee recommends concurrence in Resolution G-55A.

### Rationale:

The Committee believes that the neo-liberal discourse in the media must be addressed.

Composite Resolution G-57A (which covers Resolutions G-57 and G-58) Commercialization of Knowledge 1

**ORIGINATOR: STEP 10800** 

The Committee created Composite Resolution G-57A further to Resolutions G-57 (STEP 10800) and G-58 (ASSEP 17753), which reads as follows:

**COMMERCIALIZATION OF KNOWLEDGE 1** 

ORIGINATOR: STEP 10800 LANGUAGE OF ORIGIN: F

**WHEREAS** knowledge is not a commodity and the production of knowledge must benefit the advancement of humanity as a whole;

**WHEREAS** the way research is funded is intrinsically linked to its production;

WHEREAS PSAC is a key player in defending knowledge workers;

**BE IT RESOLVED THAT** PSAC-Quebec publicly condemn budget cuts within federal and provincial granting agencies;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec conduct a study on the direct impact of these cuts on the student employees, research professionals and postdoctoral fellows it represents.

The Committee recommends concurrence in Resolution G-57A.

#### Rationale:

The Committee estimates the cost of such a study to be approximately two thousand dollars (\$2,000). That amount would be deducted from the political action budget.

## Removal from the Resolutions of Record

The Committee recommends removing the following set of resolutions:

## 1996/GT-1 Sharing of Area Council minutes among regions

BE IT RESOLVED THAT Area Councils share minutes of their meetings;

**BE IT FURTHER RESOLVED THAT** every Area Council prepare a summary of activities being held in other regions, when necessary and timely.

#### Rationale:

This provision is now in the PSAC-Quebec By-Laws.

### 1999/G-1 Facilitators' Network

**BE IT RESOLVED THAT** PSAC-Quebec commit to activating the Facilitators' Network in Quebec:

**BE IT FURTHER RESOLVED THAT**, as of the fall of 1999, all PSAC-Quebec union education courses, except for in-residence courses, be delivered or observed by at least one member facilitator.

#### Rationale:

The Alliance Facilitators (AF) network is up and running under the purview of the Education Committee.

## 2002/G-5 (Part 1) Joint Career Transition Committee (JCTC)

**BE IT RESOLVED THAT** regional offices send minutes of this committee to all PSAC-Quebec bodies (Quebec Council, national officers, locals).

#### Rationale:

The Joint Career Transition Committee no longer exists.

## 2002/G-15 Participation of PSAC locals in FTQ Area Councils

**BE IT RESOLVED THAT** regions encourage locals to participate in FTQ Area Councils.

This resolution is part of Regulation 8 of PSAC-Quebec's By-Laws and Regulations.

## 2005/G-1A Adoption of federal anti-scab legislation

**BE IT RESOLVED THAT** PSAC-Quebec make every effort and devote all of its energies to supporting a bill in order to have the House of Commons bring in anti-strikebreaker legislation that would cover federal government workers.

#### Rationale:

This resolution is covered in Resolutions 2005 G-1A and 2001 G-121 Adoption of federal anti-scab legislation

## 2005/G-4A "Eau Secours", Quebec coalition for responsible water management

**BE IT RESOLVED THAT** PSAC-Quebec support "Eau Secours", the Quebec coalition for responsible water management;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec urge locals to support "Eau secours", the Quebec coalition for responsible water management.

#### Rationale:

This resolution is covered in Resolution 2008 G-11. Amendment to the Canada Labour Code (anti-scab legislation). However, the Committee noticed an error in the title of the resolution. It should be read now: "Eau secours", the Quebec coalition for responsible water management.

## 2005/G-6 PSAC-Quebec Website

**BE IT RESOLVED THAT** PSAC-Quebec make its website more user-friendly;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec create a "What's new" component to be regularly updated.

#### Rationale:

This resolution is covered in Regulation 10 of PSAC-Quebec's By-Laws and Regulations.

## 2005/G-15 (Note) Parallel court system in Canada

**BE IT RESOLVED THAT** PSAC-Quebec mobilize and denounce any attempt to institute in Canada a parallel court system, including a religious tribunal;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec mobilize and denounce any attempt to adopt legal provisions that are either sexist or contrary to basic human rights;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec urge the next PSAC Triennial Convention to adopt a similar resolution.

Note: Unfortunately, this resolution was not referred to the 2006 PSAC Convention as planned because it was forgotten. However, after checking with the PSAC National Office, a similar resolution was referred to the 2006 PSAC Convention General Resolutions Committee and will be debated at that Convention to be held in Toronto, from May 1 to 5, 2006.

#### Rationale:

This resolution of record was passed at the 2006 PSAC Convention. Moreover, it is a political position adopted by PSAC-Quebec.

## 2005/G-25 Unionized hotels and purchase of union-made goods

**BE IT RESOLVED THAT** the source of goods be researched for every purchase made by PSAC-Quebec and PSAC;

**BE IT RESOLVED THAT**, when there is a call for tender on these goods, a minimum standard be established: union/Quebec/Canada-made, according to Quebec, Canadian or North American manufacturing standards;

**BE IT FURTHER RESOLVED THAT** the same criteria apply to the choice of hotels.

## Rationale:

This resolution is covered in Regulation 11 of PSAC-Quebec's By-Laws and Regulations.

## 2005/S-26A (Note) PSAC structure committee

**BE IT RESOLVED THAT** that a committee made up of members in good standing be struck once this resolution has been adopted to study the national and regional union structure as a whole:

**BE IT FURTHER RESOLVED THAT** this committee report to the next PSAC Triennial Convention in 2006 and that, subsequently, recommendations be submitted to the PSAC Triennial Convention in 2009.

Note: This resolution was under "By-laws" although it should have been under "General resolutions".

#### Rationale:

The committee disbanded after fulfilling its mission.

## 2008 G-38 Promoting unionization

**BE IT RESOLVED THAT** PSAC-Quebec commit to promoting within all PSAC bodies, including the National Triennial Convention, the allocation of resources necessary for organizing and strengthening Quebec locals.

## Rationale:

This resolution is covered in General Resolution 2017 G-67A.

## 2008 G-35 Security and Prosperity Partnership of North America (SPP)

**BE IT RESOLVED THAT** PSAC-Quebec denounce the SPP, its bargaining process and its devastating effects on the environment, the economy and the sovereignty of Quebec and Canada;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec support action criticizing and denouncing the security and prosperity partnership of North America.

#### Rationale:

This resolution is obsolete.

## 2008 G-26 Public Service Employment Act (PSEA)

**BE IT RESOLVED THAT** PSAC-Quebec pressure the federal government to reinstate the former staffing system so that candidates applying for a federal government position be classified by rank.

#### Rationale:

This resolution is obsolete.

## 2008 G-12 Environmental responsibility at PSAC-Quebec activities

**BE IT RESOLVED THAT** PSAC-Quebec prepare a guide on the organization of environmentally responsible activities (conferences and conventions);

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec request that all bodies organizing events be as environmentally responsible as possible.

#### Rationale:

This resolution is obsolete.

## 2008 G-25 Public Service Employment Act (PSEA)

**BE IT RESOLVED THAT** PSAC-Quebec pressure the Public Service Commission (PSC) so that the process include rather than exclude all Canadians;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec lobby the PSC so that anyone wishing to apply for a position at the PSC may also do so by mail or fax.

This resolution is obsolete.

## 2011 G-78 Financing of University Research

**BE IT RESOLVED THAT** PSAC-Quebec engage in political action so that governmental granting agencies take into account wages negotiated into collective agreements when allocating grants, starting now;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec is working toward increasing the budgets of these organizations to maintain the jobs of its members.

#### Rationale:

This resolution is covered in General Resolution 2017 G-1A.

## 2011 G-104 Commission of inquiry into the construction industry

**BE IT RESOLVED THAT** PSAC-Quebec lobby the Quebec government so that a commission of inquiry be set up as soon as possible to look into the construction industry.

#### Rationale:

The matter is closed (refer to the Charbonneau Commission).

## 2011 G-55 Resolution for the FTQ campaign « Une retraite à l'abri des soucis »

**BE IT RESOLVED THAT** PSAC-Quebec urge its members to pressure federal members of Parliament and members of the National Assembly to support improving the Régime des rentes du Québec and its equivalent in other provinces, such as the Canada Pension Plan.

This resolution is covered in General Resolution 2017 G-16.

## 2011 G-7 Elimination of health tax

**BE IT RESOLVED THAT** PSAC-Quebec lobby the provincial government and/or candidates from all parties during the next provincial election campaign to abolish the health tax:

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec directly and actively denounce any type of deductible.

#### Rationale:

This resolution is obsolete. Elimination of the health tax is expected in 2017.

## 2011 G-35 Minimum wage to reach the low-income cut-off

**BE IT RESOLVED THAT** PSAC-Quebec pressure the Quebec government to increase minimum wage to \$10.90 per hour as of May 1, 2012;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec also ensure that the Quebec government automatically increase the minimum wage based on the Consumer Price Index (CPI) from the previous year.

#### Rationale:

This resolution is covered in General Resolution 2017 G-28A.

## 2011 G-38 Review income tax for individuals and private business

**BE IT RESOLVED THAT** PSAC-Quebec pressure the Quebec government to gradually create several new tax brackets for individuals whose income exceeds \$77,140 (the last provincial tax bracket at this time) so that the most highly paid members of society pay their fair share of taxes;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec pressure the Quebec government to gradually adjust the tax rate on profits for all private businesses on the Quebec territory so that it is equal to the share paid by individuals.

This resolution is covered in General Resolution 2017 G-39A.

#### 2011 G-56 RRQ increase

**BE IT RESOLVED THAT** PSAC-Quebec lobby the Quebec government to double RRQ benefits to increase minimum benefits for all Quebeckers and set the cap at a higher wage level.

### Rationale:

This resolution is covered in General Resolution 2017 G-16.

## 2011-G-84 Training on Section 11 8 a) of the PSAC Constitution

**BE IT RESOLVED THAT** PSAC-Quebec establish and provide necessary training pursuant to the requirements of PSAC Constitution Article 11 8 a).

#### Rationale:

This resolution is covered under multi-content training for the university sector.

#### 2014-G-1 2014-2015 PSAC-Quebec Political Action Plan

**BE IT RESOLVED THAT** PSAC-Quebec implement a response plan to stop the rise of the right wing in its tracks, both in the National Assembly and in the Commons;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec concentrate the lion's share of its resources in the Quebec region from now until the federal election in 2015;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec involve its members in this response campaign and work in co-operation with other unions and with civilian society.

#### Rationale:

The political action plan in this resolution has already been carried out.

## 2014-G-13 Transfer of Ste. Anne's Hospital

**BE IT RESOLVED THAT** PSAC-Quebec pressure the governments;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec do everything in its power to protect the interests of Ste. Anne's Hospital employees.

#### Rationale:

This resolution is obsolete. The transfer has already been completed.

## 2014-G-23 Creation of a Standing Committee on Pensions on the PSAC NBoD

**BE IT RESOLVED THAT** PSAC, Quebec Region, support and request the creation of a standing pensions committee on the PSAC National Board of Directors, with a mandate to assist and mobilize PSAC and APSAR members.

#### Rationale:

This resolution is obsolete. A pension committee is already in place at PSAC.

## 2014-G-4A Orphan clauses

**BE IT RESOLVED THAT** PSAC-Quebec's position is against incorporating orphan clauses in collective agreements;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec, along with all of its union allies, pressure the various levels of government to amend the Canada Labour Code and the relevant provincial legislation to this effect.

#### Rationale:

This resolution is covered in General Resolution 2017 G-62A.

## 2014-G-7 FINANCING OF UNIVERSITY RESEARCH

**BE IT RESOLVED THAT** PSAC-Quebec engage in political action so that governmental granting agencies take into account wages negotiated into collective agreements when allocating grants, starting now;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec is working toward increasing the budgets of these organizations to maintain the jobs of its members.

# Rationale:

This resolution is covered in General Resolution 2017 G-1A.

# 2014-G-16 Missing or murdered Aboriginal women

**BE IT RESOLVED THAT** PSAC-Quebec encourage its members to pressure federally and provincially elected officials to immediately launch, in consultation with the Aboriginal women and their representatives, a national commission of inquiry on missing or murdered aboriginal women.

#### Rationale:

A national inquiry has been ordered.

# 2014-G-37 Availability of training in English

**BE IT RESOLVED THAT** PSAC-Quebec begin offering some of its basic courses in English at least once a year, including courses on grievance resolution, introductory courses for union local officers, and courses on occupational health and safety, ways of dealing with the employer and political action;

**BE IT FURTHER RESOLVED THAT** these courses be offered, if at all possible, on weekends.

#### Rationale:

PSAC-Quebec also offers training in English.

# 2014-G-38 Training for members in the university sector

**BE IT RESOLVED THAT** the PSAC-Quebec Education Department develop and offer, in collaboration with the Conseil québécois des syndicats universitaires (CQSU), a training program specific to the university sector.

#### Rationale:

Multi-content training is already available.

# 2014-G-43 Opening of union education to community groups

**BE IT RESOLVED THAT** the FTQ, Area Councils and the affiliated unions invite community groups of their choice to take union training with their members.

### Rationale:

This resolution was not admissible at the 2014 Convention because PSAC-Quebec does not have authority on the issue.

# 2014-G-10 Budget cuts in granting agencies

**BE IT RESOLVED THAT** PSAC-QUEBEC denounce the budget cuts of federal and provincial granting agencies;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec demand massive funding for fundamental and applied research intended for a non-commercial purpose;

**BE IT FURTHER RESOLVED THAT** PSAC-QUEBEC produce a study on the direct impacts of cuts on student employees, research professionals and postdoctoral fellows.

# Rationale:

This resolution is covered in General Resolution 2017 G-1A and 2017 G-57A.

# 2014-G-44 PSAC-Quebec subscribes to the Kyoto Protocol

**BE IT RESOLVED THAT** PSAC-Quebec pressure the federal government to have Canada regain its place among the leading countries working to reduce the effect of climate change on the environment.

### Rationale:

Canada made a commitment at the 21st Conference of Parties (COP21) (which encompasses the Kyoto Protocol) in November 2015.

# Resolutions with recommendation for rejection

Composite Resolution G-24 (Part 2) (which covers Resolutions G-21, G-22 and G-23)

#### Harassment

Originator: STEP 10800

## Part 2:

The Committee recommends non-concurrence in Part 2 of Resolution G-24 which reads as follows:

HARASSMENT

ORIGINATOR: STEP 10800 LANGUAGE OF ORIGIN: F

**WHEREAS** close to one out of six student workers is a victim of harassment in the university work environment;

**WHEREAS** this is an under-reported problem;

**BE IT RESOLVED THAT** PSAC-Quebec commit to actively combatting harassment of any kind;

**BE IT FURTHER RESOLVED THAT** PSAC-Quebec provide financial, human and material resources to locals planning initiatives to address the problem.

#### Rationale:

The Committee recommends that the second BIR be rejected, because PSAC-Quebec does not have the authority to adopt a resolution that would require an increase in union dues.

Composite Resolution G-25A (which covers Resolutions G-25, G-26 and G-27) **Unpaid Internships** 

Originator: ASSEP 17753

The Committee created Composite Resolution G-25A further to Resolutions G-25 (ASSEP 17753), G-26 (Québec Area Council), G-27 (STEP 10800), which reads as follows:

**UNPAID INTERNSHIPS** 

**ORIGINATOR: STEP 10800** LANGUAGE OF ORIGIN: F

WHEREAS many trainees and interns are currently not being paid for their 40-hour work week and must take on additional part-time work to make ends meet;

WHEREAS trainees and interns work as hard as employees and receive no remuneration:

WHEREAS an education should not be obtained at the expense of a student's quality of life:

BE IT RESOLVED THAT PSAC pressure the provincial and federal governments to prohibit unpaid placements and internships;

BE IT FURTHER RESOLVED THAT all trainees and interns working at PSAC, or for one of its bodies or locals, be remunerated.

The Committee recommends NON-CONCURRENCE in the second BIR in divided Resolution G-25A.

#### Rationale:

PSAC does not have authority over other PSAC bodies and its locals. Nonetheless, the Committee would like to point out that PSAC-Quebec pays all of its interns as prescribed in its employees' collective agreement.

**Resolution G-44** 

Importance and role of the union

**ORIGINATOR: USGE 10036** 

The Committee recommends non-concurrence in Resolution G-44, which reads as follows:

**WHEREAS** the union has been fighting to obtain better working conditions for members, including benefits

**WHEREAS** members must be made aware of the importance of our union;

**BE IT RESOLVED THAT** PSAC tailor its training to all of its members on the importance of being represented by a union;

**BE IT FURTHER RESOLVED THAT** the training be aimed at informing, mobilizing and educating PSAC members.

**Rationale:**
